Procedure	Into a suitable vessel equipped with heating, cooling, and agitation, add Deionized Water. Begin to mix, heat to 70-75°C (158-167°F). Add Stearamidopropyl dimethyl amine, STEPANQUAT® GA-90 and CETYL ALCOHOL, NF. Emulsify for 30 minutes and maintain the temperature between 70°C–75°C (158°F–167°F). Cool to 38°C–48°C (100°F–118°F). Add Potassium Chloride dissolved in water. Mix well. Add Cyclomethicone and Cationic Emulsion 929. Adjust pH to 3.5–4.5 with Citric Acid and Sodium Hydroxide if necessary. Cool to ambient temperature with continuous agitation. Add fragrance, dye and preservative, as desired.
