Procedure	<ol style="list-style-type: none"> 1. Charge Deionized Water, STEPANATE® SXS, and Isopropyl Alcohol. 2. With good agitation, slowly blend in Sodium Citrate and STEPANOL® WA-EXTRA HP. 3. Adjust pH to between 8 and 9 with Citric Acid, anhydrous. 4. Once clear, add BIO-SOFT® EC-639. 5. Add Fragrance, Preservative and Dye as needed. 6. Mix until homogenous.
