Procedure	Prepare Phase 1 by combining first four ingredeints in a container and heat to 165°F with mixing. When uniform, cool to 110°F. Meanwhile, in a separate container, combine Phase 2. Mix until Irgansan DP 300 is dissolved. Add to Phase 1. While mixing, add first two ingredients from Phase 3. Adjust pH to 6.0–6.5 with Sodium Hydroxide. Adjust viscosity with Sodium Chloride, if necessary. Add Fragrance, Dye, and Preservative as desired.
